- 2. Vendor's sales location will be assigned based on space requirements and logistic considerations.
- 3. Vendor Package will be available at the Registration Booth from Saturday, April 25 through Wednesday, April 29 from 9:00AM to 5:30PM.
- 4. Set up of tent and sales area may begin Saturday, April 25 and must be completed by 5:30PM on Wednesday, April 29.
- 5. Vendor will be open for business from 7:30AM to 5:30PM on all match days, starting Thursday, April 30, until 12:00 noon on Sunday, May 3.
- 6. Vendors may begin tear down no earlier than 12:00 noon on Sunday, May 3.
- 7. Vehicles are not allowed in sales area on match days from 7:30AM to 5:30PM, or before 12:00 noon on Sunday, May 3.
- 8. Tent top and sides (if used) will be white.
- 9. Vendor will provide own power.
- 10. No alcohol will be consumed during the official hours that the range is hot.
- 11. Security is not provided and 5 Dogs Creek and all persons associated with hosting the event do not assume liability for lost, stolen or damaged items.
