The undersigned, as an authorized representative, is applying to be a vendor at the SHOOTOUT and agrees to the terms and conditions set forth in this agreement:

- 1. No later than March 28, 2011, Vendor agrees to deliver 100% of the Vendor Application Fees, signed AGREEMENT, completed APPLICATION, and signed RELEASE to Sunshine Kid, 2713 West 155th Street, Gardena, CA 90249. Check payable to "5 Dogs Creek".
- 2. Set up of sales area may begin Saturday, April 23 and must be completed by end of day on Wednesday, April 27. NOTE: In observance of Easter, on Sunday, April 24 between 12:00 noon to 5:00PM the range owners have stipulated no work take place.
- 3. Vendor will be open for business by 9:00AM on all match days, starting Thursday, April 28, until 12:00 noon on Sunday, May 1.
- 4. Vendors may begin tear down no earlier than 12:00 noon on Sunday, May 1.
- 5. Vehicles are not allowed in sales area on match days between 7:30AM to 5:30PM, or before 12:00 noon on Sunday, May 1.
- 6. Retail atmosphere: Merchandise must be CAS appropriate; tent must be white/beige canvas; vendors must dress in appropriate country/western or period correct attire; any music played onsite must be country/western or period correct.
- 7. Vendor will provide own power.
- 8. No alcohol will be consumed during the hours that the range is declared hot.
- 9. Replica guns for sale or display will be treated as if they are real firearms and all SASS rules apply.
- 10. Security is not provided and 5 Dogs Creek and all persons associated with hosting the event do not assume liability for lost, stolen or damaged items.
